Proclamation 4 of 2023

PROCLAMATION

by

- HIS EXCELLENCY THE HONOURABLE Emmerson Dambudzo Mnangagwa, G.C.Z.M., President of Zimbabwe and Commander-in-Chief of the Defence Forces of Zimbabwe;
- WHEREAS, section 143(1) of the Constitution, provides that Parliament is elected for a five year term which runs from the date on which the President-elect is sworn in and assumes office in terms of section 94(1)(a) of the Constitution;
- AND WHEREAS, after the last election, the President was sworn in on the 26th day of August, 2018, and the five year period ends on the 25th day of August, 2023;
- AND WHEREAS section 144(1) of the Constitution provides that where Parliament has not earlier passed resolutions to dissolve in terms of section 143(2), the President must by proclamation call and set dates for a general election to be held within a period prescribed in section 158;
- AND WHEREAS, in terms of section 158(1)(a) of the Constitution, a general election must be held so that polling takes place not more than thirty days before the expiry of the five year period specified in section 143;
- AND WHEREAS it is provided by section 38 of the Electoral Act [Chapter 2:13], that in a proclamation fixing dates for the holding of an election to the office of President, a general election and elections for councillors, the President, after consultation with the Commission shall provide for the matters required by the said section 38;
- AND WHEREAS it is provided by section 38 as read with section 45C of the Electoral Act [Chapter 2:13], that the nomination of party-list candidates for the Senate, the National Assembly and provincial councils shall take place on the same day and venue as the nomination for the constituency National Assembly candidates;

AND WHEREAS the Zimbabwe Electoral Commission, has conducted a delimitation of the electoral boundaries as provided by section 161(1) of the Constitution and the President has published a proclamation in the *Gazette* in terms of section 161(11) of the Constitution declaring the names and boundaries of the wards as determined by the Commission, the new boundaries of provinces, constituencies and wards shall apply for the purposes of this election:

NOW, THEREFORE, under and by virtue of the powers vested in the President as aforesaid, I do, by this proclamation—

- (f) for the purpose of section 120(1)(b) and (c) of the Constitution, as read with section 38(3) of the Electoral Act [Chapter 2:13] and section 35 of the Traditional Leaders Act [Chapter 29:17]—
 - (i) determine that the Provincial Assemblies of Chiefs shall meet on the 3rd day of August, 2023, at the following times and places to elect the following number of chiefs to the Council of Chiefs—
 - A. the Provincial Assembly of Chiefs for Manicaland Province shall be convened at the Chiefs' Hall, Mutare, at 10 o'clock in the morning for the purpose of electing five Chiefs representing the said province to be member of the Council of Chiefs; and

- G. the Provincial Assembly of Chiefs for Matabeleland South Province shall be convened at the Government Buildings, Gwanda, at 10 o'clock in the morning for the purpose of electing four chiefs representing the said province to be members of the Council of Chiefs; and
- H. the Provincial Assembly of Chiefs for Midlands Province shall be convened at the Chief's Hall, Senga, Gweru, at 10 o'clock in the morning for the purpose of electing four chiefs representing the said province to be members of the Council of Chiefs; and
- (ii) determine that the Council of Chiefs elected in terms of subparagraph (i) shall be convened at Mukwati

- Building, Harare, on Thursday the 10th day of August, 2023, at 10 o'clock in the morning for the purpose of electing the President and the Deputy President of the Council of Chiefs, who shall be *ex officio* Senators; and
- (iii) in relation to the election of the sixteen Chiefs referred to in section 120(1)(b) of the Constitution, determine that—
 - A. the electoral college constituted by the Provincial Assembly of Chiefs for Manicaland Province shall be convened at the Chief's Hall, Mutare, on Thursday the 24th day of August, 2023, at 10 o'clock in the morning for the purpose of electing two Chiefs to be Senators representing the said province; and
 - B. the electoral college constituted by the Provincial Assembly of Chiefs for Mashonaland Central Province shall be convened at New Government Buildings, Bindura on Thursday the 24th day of August, 2023, at 10 o'clock in the morning for the purpose of electing two Chiefs to be Senators representing the said province; and
 - C. the electoral college constituted by the Provincial Assembly of Chiefs for Mashonaland East Province shall be convened at Mbuya Nehanda Hall, Marondera, Thursday the 24th day of August, 2023, at 10 o'clock in the morning for the purpose of electing two Chiefs to be Senators representing the said province; and
 - D. the electoral college constituted by the Provincial Assembly of Chiefs for Mashonaland West Province shall be convened at Cooksey Memorial Hall, Chinhoyi, on Thursday the 24th day of August, 2023, at 10 o'clock in the morning for the purpose of electing two Chiefs to be Senators representing the said province; and

- E. the electoral college constituted by the Provincial Assembly of Chiefs for Masvingo Province shall be convened at Chief's Hall on Thursday the 24th day of August, 2023, at 10 o'clock in the morning for the purpose of electing two Chiefs to be Senators representing the said province; and
- F. the electoral college constituted by the Provincial Assembly of Chiefs for Matabeleland North Province shall be convened at Chief's Hall, Ntabazinduna, on Thursday the 24th day of August, 2023, at 10 o'clock in the morning for the purpose of electing two Chiefs to be Senators representing the said province; and
- G. the electoral college constituted by the Provincial Assembly of Chiefs for Matabeleland South Province shall be convened at Government Buildings, Gwanda, on Thursday the 24th day of August, 2023, at 10 o'clock in the morning for the purpose of electing two Chiefs to be Senators representing the said province; and
- H. the electoral college constituted by the Provincial Assembly of Chiefs for Midlands Province shall be convened at Chief's Hall, Senga, Gweru, on Thursday the 24th day of August, 2023, at 10 o'clock in the morning for the purpose of electing two Chiefs to be Senators representing the said province.
