





The concept of devolution recognises the transfer of funding and powers from the national government in Harare to provincial and local authorities.

#### **Devolution thrust rests on:**

- Localised decision-making that is context-specific and sensitive to community-based needs.
- Decentralisation is a holistic, sustainable, inclusive economic growth and developmenT approach.
- Local government should be civic-oriented and focused on addressing the much-needed infrastructure in health, education, roads, housing and human settlements.

### **Central Government**

Under President Kasukuwere's leadership, the national government's role is to make laws, set policies and implement services that fall under the auspices of national and sovereign competencies, including Defence, Home Affairs and the Judiciary.

### The hallmark of the delivery of our services shall be:

- Devolution.
- Meritocracy.

In Zimbabwe, political progress has not always aligned with the country's changing social, economic, and political needs. This has resulted in limited participation from citizens in national political discussions. President Kasukuwere's leadership aims to address this issue through a RENEWAL agenda focusing on improving politics, governance, and foreign policy.

In the first 100 days of our administration, we will embark on a transformative journey to redefine Zimbabwe's domestic foreign policy, centered on the reconceptualization of our national brand identity anchored by strong family values and cultural diplomacy. Our nation's unique tapestry throughout history embraces the essence of family values, unity, and inclusivity. Our engagement with the world will serve as a beacon of hope – a Zimbabwe that cherishes its heritage and fosters global partnerships for mutual progress.

### **Fostering a Political Culture of Accountability**

The developmental state philosophy has resulted in too much government involvement in important areas such as politics, society, and the economy. Under the leadership of President Kasukuwere's Renewal Plan, it acknowledges that a truly developmental state approach is necessary for Zimbabwe to achieve political accountability, economic growth, and a strong national identity. Achieving these goals requires prioritising political accountability and creating a culture that supports it.

### This is based on the idea that a renewed state should:

- Act as the forerunner of the hopes and freedoms of the Zimbabwean citizens
  The government should establish a social contract with its citizens that promotes a political culture of accountability involving all stakeholders, institutions, and actors.
- Create an enabling environment for wealth creation

### This Political Culture of Accountability seeks to achieve the following:

- Making political disagreements legitimate as enshrined in the constitution. This seeks to create a society tolerant of political differences.
- Political programs should prioritise issue- based approaches over ideological or polarised ones.
- The critical role of non-state actors includes civil society, individuals, the business community, academia, and other pressure groups in state affairs.
- The constitution should be empowered to safeguard the rights of citizens from the state.
- A reformed coalition approach in which the state regards the private sector as a social partner in Zimbabwe's reconstruction agenda.
- The state is responsible for creating, implementing, and commemorating political, historical, and cultural events and programs promoting inclusivity, belonging, and national identity.

### **Reconciling National Healing, Sense of Belonging and National Identity**

As citizens of Zimbabwe, we recognise the importance of unity in fostering a sense of belonging and national identity. This foundation was crucial to our attainment of independence in 1980. Unfortunately, misunderstandings and conflicts among different groups, such as those who fought for our freedom, inter-ethnic disagreements, political disputes, and a strained relationship between the government and its people, have threatened our national identity. Under the leadership of President Kasukuwere, we commit to reconciling our nation and working towards a vision of a more united and harmonious Zimbabwe.

### We will pursue restorative justice through three main pillars:

- Pillar One: Harms and Needs: an acknowledgement of the harm inflicted on specific victims and the concerns for their needs.
- **Pillar Two:** Obligations: a declaration that perpetrators have an obligation to accept their fault and repair the harm inflicted.
- Pillar Three: Engagement: acknowledging that addressing crime is an inclusive approach involving victims, perpetrators, the state and civil society.





### GOVERNANCE

#### **Electoral Reforms**

- Electoral reforms are key to a responsive approach to the social contract between the state and its citizens.
- Enhancing the responsiveness of electoral processes to the national question and society's expectations.
- Reforming the electoral process attains transparency, impartiality, accuracy, integrity, and inclusiveness in Zimbabwe.

#### There are three areas of focus in our electoral reform agenda:

- Political changes, including the Zimbabwe Electoral Commission's autonomous, transparent, and influential role. This also includes a transparent framework for ZEC's accountability and funding.
- Administrative changes include adopting innovative procedures and policies, including ZEC's financial integrity, procurement, and staffing models. Furthermore, the changes should reflect ZEC's capacity to embrace the electoral society's specific needs and adopt ICTs for voter registration, voting and the electoral processes.
- Legal changes should speak to ZEC's commitment to its constitutional reforms, electoral laws and policies that enhance its integrity.
- Facilitate and implement (activate the Diaspora vote)

#### **Civil Service Sector Reforms**

The Zimbabwean Constitution is clear on the principles governing the civil service sector. Consequently, the leadership of President Kasukuwere pledges to reform the civil service to enhance the sector's efficiency, representative, democratic and professional character through the following:

- Decent work principle in harmony with the International Labour Organisation laws to mitigate wage gaps in the public civil service.
- To ensure continuous compliance with governance standards, random audits shall be conducted.
- Right sizing the civil sector is key for Zimbabwe, a smaller country which is vulnerable to internal and external shocks.

## **FOREIGN POLICY**

At the turn of the millennium, Zimbabwe experienced an unprecedented socioeconomic and political crisis. At the local level, the crisis caused a significant shift in the country's political economy, which affected the country's global choices. Significantly:

- The crisis has limited Zimbabwe's meaningful commitments at bilateral, multilateral, regional and global levels.
- A surge in a Zimbabwean diaspora community, a key human resource component
- Though the country has sought to attract foreign investment, enhance regional cooperation, and secure debt relief to alleviate the country's economic challenges, the legitimacy crisis of recent political events and the slow progress of reforms have reduced the country's value addition to the global system.

The leadership of President Kasukuwere pledges to drive a foreign policy agenda which bridges domestic preferences (reviving Zimbabwe's political and socioeconomic fortunes) and external developments (growing multilateralism, which creates conditions or cooperation).

### Zimbabwe's national interests include:

- Activating the Diaspora vote.
- Creating conditions for the diaspora return.
- Removal of sanctions.
- Multilateralism.
- Economic recovery.
- Re-engagement and reintegration into the global community; and
- State sovereignty and territorial integrity.

# ECONOMY OVERVIEW





At the outset, it is critical that we have an economic philosophy. We believe in building a new democratic developmental state in Zimbabwe in which there is

- A government with the political will and legitimate mandate to perform the required functions.
- An institutionalised process where the bureaucracy and government engage with other stakeholders.
- An established development framework and a comprehensive governance system to ensure the programme is implemented e.g., a central function responsible for overall co-ordination.

### Key and urgent challenges under the current economy include:

- Promoting and supporting value addition and beneficiation.
- Accelerating the transformation and development of the rural economy.
- Increased investment in the productive sector.
- Infrastructure rehabilitation and development.
- Re-engagement with the regional and global economies.

67% of Zimbabweans reside in the rural economy. Our primary objective will therefore focus on the accelerated and inclusive transformation and

- Macroeconomic stability.
- Effective currency management.
- Dealing with inflation.
- Employment creation.
- Poverty alleviation and broad-based economic development.
- Economic devolution.
- Debt resolution.
- Fiscal discipline.
- Dealing effectively with corruption; and

development of the rural economy~ Saviour Kasukuwere Cur government will spend your tax revenue in a responsible and transparent manner to deliver essential services to citizens.

Successfully managing government revenues and expenses is crucial for creating a stable macroeconomic environment. This stability can then attract investments, provide affordable public goods and services, invest in the economy's productive sector, build new infrastructure, and establish adequate social safety nets.

#### In pursuance of this, we will:

- Maintain the budget deficit to a minimum of the SADC macroeconomic convergence benchmark of 3% of GDP.
- Streamline and implement effective revenue collection methodologies where we will upgrade ZIMRA capacity, skills, and technological systems.
- Minimise tax avoidance and evasion.
- •Manage public expenditure by ensuring that public funds are used effectively and efficiently without compromising our integrity, competitiveness, and transparency.
- Rationalise and limit the percentage of employment costs and ensure that civil servants are well remunerated.
- Implement reforms of the public procurement processes to ensure efficiency and transparency.
- Manage public debt and ensure that it remains within the Public Debt Management Act target of 70% and ensure that loans procured are primarily for productive and not consumptive expenditures.
- Reform state enterprises to minimise contingent liabilities from State-Owned Enterprises (SOE) and gain productive efficiencies.
- Implement stringent cash budgeting measures.
- Ensure that we allocate financial resources to developing the rural

economy and alleviating poverty.

Have a subsidies approach which does not create market inefficiencies.



## **MONETARY POLICY**

The essence of monetary policy through the Reserve Bank of Zimbabwe (RBZ) is to protect the value of our currency, manage inflation, issue banknotes and coins, manage money supply, be the custodian of gold and other mineral and foreign assets, be the banker and advisor to government, and be the lender of last resort and banking of the regulator stability, sector to ensure confidence and compliance.

Without sound money, there are no morals. It is a fact that no country can ever succeed without its own stable and well-managed currency. Currencies become stable not only because of sound economic policies but also responsible political leadership and the existence of institutional integrity. Zimbabwe's currency woes must be resolved urgently and immediately to create macroeconomic stability, team inflationary pressures, and promote economic growth and development.

Monetary Policy does not operate in a vacuum but must be complementary to fiscal policy. Added to this is the issue of currency and exchange rate management to always ensure macroeconomic stability.

#### Our policy will seek to:

- Have a truly independent Reserve Bank focusing on its core business with zero quasi-fiscal activities.
- Move away from the current multi-currency regime to mono currency once conditions pertain in a responsible, informed, and measured manner which avoids systemic risk,

creates confidence and market stability and avoids loss of asset values and incomes.

- We will ensure a market-driven approach to foreign exchange rates and the pricing of public and private goods and services.
- Minimise the cost of credit, especially to SMEs to stimulate economic growth.
- Pursue financial inclusion strategies which take advantage of ICT.
- Promote a savings culture with an intended benchmark of 25% of GDP.
- Beef up financial intelligence skills and capacity to stem illicit funds flows, financial crimes, and corruption in general.

Ensure total independence of the Monetary Policy Committee, whose members must be appointed on merit and experience.

# **MINING POLICY**

# THE MINING SECTOR IN ZIMBABWE CONTINUES TO BE FACED WITH A MYRIAD OF PROBLEMS WHICH NEED URGENT ATTENTION.

### **These includes**

- Opaque mining deals and projects.
- Power supply shortages and interruptions.
- Corruption resulting in serious leakages.
- Inadequate long-term capitalisation and financing.
- Dilapidated infrastructure, inefficient rail and telecoms system.
- Environmental degradation due to illegal mining operations.
- Skills flight.





The key success factors for the effective management and allocation of mining resources, among others, lie in:

Amending the Mines and Mineral Act. It is imperative that local communities possess a minimum of 26% ownership in the beneficiation process to guarantee the growth and advancement of their development.

- Assessing our resources based on worldwide benchmarks rigorously. This will involve a comprehensive analysis of our subterranean assets. We will categorise our mineral resources according to established global standards, such as JORC.
- Policy consistency and accountability.
- It is imperative that small-scale miners receive legal recognition, formalisation, and promotion.
- Improving the mineral sector requires a significant overhaul of its institutional arrangements. One key aspect to focus on is deregulating mineral marketing.
- Corruption and illicit fund flows will be met with a crackdown.
- Differentiating between hard rock mining and alluvial mining is essential to make taxation laws more effective, fair, and less complicated.
- Our assessment of capital mobilisation encompasses both valued and undervalued assets.
- Rehabilitation of viable old mines to give greater opportunity and maximise the benefits. Infrastructure development.
- Establishing a well-managed Sovereign Wealth Fund





# SOVEREIGN WEALTH FUND

As we envision a brighter future for Zimbabwe, we recognize the potential of our Sovereign Wealth Fund to be a powerful catalyst for positive change. Building on its existing foundation, we propose to strengthen its role and impact, amplifying its capacity to serve the best interests of our people. With a commitment to transparency, accountability, and inclusive growth, our unique proposition aims to unlock the full potential of the Sovereign Wealth Fund, driving socio-economic progress and prosperity for all Zimbabweans.


Additionally, we aim to minimise risk by diversifying the investment portfolio, which may involve offshore investments if necessary.

### The SWF will be utilised to:

- Protect the economy from any unexpected external shocks.
- Investment in selected strategic sectors of the economy, for example, infrastructure development, which gives long-term benefits.
- Meeting pressing social costs which cannot be funded through tax revenues, such as education and health infrastructure, including and if necessary social safety nets.
- Funding local empowerment ventures primarily for youths and women.
- Funding industrialisation of the economy in partnership with the private sector of foreign investors.
- Environmental protection investments.

The SWF will NOT be utilised for recurrent expenditure or consumption as it is a long-term investment to build its own developmental capital base.

# AGRICULTURE

Around 11 million<sup>1</sup> hectares of arable land currently sit under the control of the government. In addition, the neglect of agricultural infrastructure maintenance since 2000 has resulted in vast pieces of productive land being underutilised and their infrastructure dilapidating.

### Our key policy positions around the land issue are:

- Land reform is irreversible but must be rationalised and monetised to become an asset with a market value.
- Land audits will be a continuous exercise with Land taxation on the value eligible for a rebate when you produce.
- All land-based policies must have the "use it or lose it policy" with all agricultural land utilised and productive.
- Every Zimbabwean citizen who owns a piece of land, whether urban or rural, deserves a title deed for secure tenure.
- We will limit and protect foreign ownership of agricultural land to 10% of total arable land.
- We will disentail cartels in the agriculture sector and promote transparency and fair competition.

### SUPPORT PLAN FOR SMALL-SCALE FARMERS: NURTURING THE BACKBONE OF AGRICULTURE

- Our priority areas will include:
- Depoliticising the land issue and focusing more on productivity, food security, diversification, and export of value-added products.
- Land ownership must be rationalised through a land usage audit and will ensure secure tenure through title deeds which can be collateralised.
- Availing long-term development capital at competitive interest rates.


### Our goal of promoting inclusive economic growth and development will focus on:



Decent work is defined by the International Labour Organisation (ILO) as being "productive work for women and men in conditions of freedom, equity, security and human dignity". It offers opportunities for work that is productive and delivers fair income. Historically the independent (informal) sector was thought to be comprised of vendors, tuckshops, SMEs and all types of small business operations; however, current trends indicate that professionals and technicians, namely, lawyers, accountants, building contractors and traders, now form a significant portion of the economy referred to as the shadow economy. In response, we will produce a well-researched and informed collective approach to facilitate the transition of the SME sector to align with best practices and standards.

#### Formalisation of the informal sector includes:

- Creating an enterprise development environment that will transition independent (informal) workers to salaried positions.
- Registering and taxing independent (informal) businesses.
- Independent (informal) workers being represented in relevant rulesetting, policymaking, and collective bargaining.
- Independent (informal) wage workers obtain a formal job or formalise their current job with a secure contract, worker benefits, and a formal trade union membership.
- Independent (informal) sector workers gaining access to legal and social protection and support services.



Unfortunately, women in Zimbabwe encounter many obstacles in accessing opportunities such as finance, land, and freehold property. Additionally, they are underrepresented in leadership and policy-making positions in both public and private sectors and face legal and cultural barriers.

#### To address these challenges:

- We will intentionally promote women's rights across all sectors of our society in accordance with the Constitution, the SADC Protocol on Gender and Development, and the Protocol to the African Charter on Human and People's Rights on the Rights of Women in Africa.
- The United Nations' Sustainable Development Goal 5 aims to "Achieve Gender Equality and Empower all Women and Girls".

#### Our plan for empowering women includes the following initiatives:

- Reforming all policies and laws to ensure they are gender sensitive.
- Incorporating gender equity issues into national and sectoral economic policies and national budget policies.
- Encouraging and incentivising women's participation in all sectors of the economy.
- Advancing women's political representation, including leadership positions in state enterprises (50% as per the Constitution).
- Improving access to financing for women in business.
- Implementing public procurement policies that support women-owned businesses.
- Promoting the development of women's entrepreneurship skills in all provinces.

In our pursuit of a sustainable and inclusive future, we acknowledge that our greatest asset lies in the hands of our children. As a nation, we have a profound responsibility to nurture, protect, and empower every child, as they represent the promise of a brighter tomorrow. Our commitment to the well-being and development of our children is not only a moral imperative but a strategic investment in the future prosperity of Zimbabwe.

We recognise that immediate efforts must be taken to protect the girl child and address the inequities that young women confront today.

#### **Challenges include:**

- Lack of access to social protection,
- Poor health care
- Lack of accessibility to quality education.
- Mental health.
- Psychosocial support services.
- Sexual abuse and exploitation.
- Child marriages.

The girl child is also compelled to assume adult tasks and is exposed to adulthood, serving as the family's primary carer. Furthermore, although the Marriages Act prohibits marriages for minors under the age of 18, the reality in Zimbabwe is that one in every three girls marries before the age of 18. Child marriage has a devastating impact on the lives of young girls. It disrupts adolescence



and frequently leads to early pregnancies with health complications and school dropout, preventing females from attaining their full potential.

#### Our plan for empowering the girl child includes the following initiatives:

- Establishment of a Gender-based Violence Command Centre.
- Establishing shelters for victims of sexual abuse.
- Removal of social and religious barriers that block the girl child's access to quality education and healthcare.
- Removal of social and religious practices that are complicit to girl child abuse.
- Provide a robust support network in partnership with communities and organisations specialising in safeguarding the girl child.
- Prioritisation of Early Childhood Development.

Youth worldwide have been acknowledged as an important human resource with the potential to contribute significantly to national development and, therefore, must be accorded such recognition and be involved in national development by the government and all other stakeholders. To avoid doubt, a youth is defined as a male or female aged between 15 and 35, per the African Youth Charter.

In Zimbabwe, 51% of our population are youths, and most are unemployed, resulting in increasing emigration numbers as our youths seek opportunities elsewhere. We must stop this brain drain by making it worthwhile for our youths to stay at home, but they must be provided with the necessary political and economic space to pursue their aspirations unhindered.

A new inclusive policy framework must be developed to harness their skills, energy, ambitions, and aspirations. Such a policy framework needs to consider how we can deliberately create an environment in all sectors of our economy which creates broad access to new opportunities and possibilities for our youths.

#### Our guiding principles include:

As we move forward, it is our duty to honour and support these heroes who have played a pivotal role in shaping our identity. We acknowledge their unique challenges, and our manifesto is founded on a deep understanding of their needs and aspirations. Our commitment is to create a thriving society that ensures the well-being and dignity of our esteemed war and liberation veterans. Veterans (liberation and war) are key in any post-conflict society. How their rehabilitation and reintegration into civilian life is managed has a bearing on how they develop their identity and role in line with the common objective of developing the state.

#### The rehabilitation and reintegration of veterans has advantages:

- It can prevent a costly and rushed response to new security threats to the country's stability posed by veterans.
- Providing a sense of identity and political inclusion in which their

#### **Objectives**

- An inclusive approach which acknowledges the sacrifices of everyone who participated in the war of liberation and state military interventions to manage the problems of entitlement and hierarchies that have become a source of political mobilisations and the distinction between 'genuine' and 'bogus' veterans.

- Set up a properly managed Trust Fund that is funded by proceeds from the key sectors of the economy (e.g. mining).
- To capacitate NSSA to ensure beneficiaries receive basic and monthly payments that retain value.

- An audit of Trust Assets and shareholding in ZIPRA and ZANLA properties, which were appropriated by the state and rogue individuals, should be returned to their rightful beneficiaries.

# EDUCATION POLICY

Education in Zimbabwe stands as a cornerstone of our nation's progress, bearing witness to the value we place on knowledge and its transformative power. In the early years of independence, commendable strides were made to broaden educational access, but challenges persist. The loss of skilled and talented individuals has hindered our education system's advancement, leading to a decline in its once sterling quality. However, we view this as an opportunity for renewal, as we vow to reignite the flame of excellence and restore our education system to its rightful place at the forefront of development and national pride.

Our mission as a new government will be to bring about significant reforms to the institutional arrangements of the sector. Our vision will be to achieve efficiency, cost-effectiveness, modernisation, and relevance while ensuring broad access and affordability for all. We will be committed to upholding high-quality standards to equip citizens for the information age.

#### The key to achieving this will be investment in:

- Infrastructure development and rehabilitation of schools, colleges, universities, training, and vocational institutions.
- Curricula upgrades and modernisation.
- The support and development of new delivery and teaching skills and capacity building.
- Pre-School
- Every child born in Zimbabwean is entitled to access to quality education from the first day.

#### To achieve this, we will:

- Provide free preschool education to all children born in Zimbabwe.
- Ensure high-quality educational standards at the preschool level.
- Provide decent transportation and feeding schemes.
- Insist on high standards of registration of all preschool providers.
- Insist on an early introduction to ICT skills.

#### Primary Education

It is crucial to recognise that primary education plays a vital role in shaping

individuals' character and unlocking their potential for success.

#### To achieve this, we will:

- Provide free primary schooling for all citizens.
- Include coverage of science, information technology in the curriculum.
- Include the study of culture and local languages.
- Establish feeding school schemes.



#### **Secondary Education**

Providing diverse career options and promoting inclusion in secondary education is paramount. This can be accomplished by offering a broader selection of high school subjects, allowing for the early recognition of skills and talents, and expanding the pool of potential career paths.

#### **Our policies will include:**

- Enhancing teaching at the secondary school level by incentivising teachers to continuously learn and upgrade their skills while also upholding the principle of decent work.
- Strengthening management capacities and arrangements at the school level with intense supervision and maintenance of high learning and teaching standards.
- Investment in upgrading infrastructure, facilities, and equipment, including universal, affordable access to the Internet.
- stablishing centres for specialised vocational and technical education in every district that will cater for diverse skills and opportunities for wealth creation and skills retention.

#### **Tertiary Education**

We are committed to ensuring that every deserving child can pursue tertiary education. Providing ample funding options for all eligible students is imperative to achieve this goal. Our policies will include:

- Upgrading all tertiary institutions' infrastructure, facilities, equipment, and teaching capacities.
- Establishing a tertiary education fund.
- Support and assist tertiary institutions to be well-funded and capacitated to deliver high levels of education.

#### Training

In 2018, a National Critical Skills Audit was conducted to evaluate the country's shortage and excess of skills. The audit confirmed that there are significant gaps between the supply and demand of skills in key sectors. There is a 68% deficit in producing qualified specialists and technicians, particularly in the fields of Natural & Applied Sciences, Engineering & Technology, Medical & Health Sciences, and Agriculture.

- Our policies will therefore seek to close this skills gap through:
- Upgrade and increase technical colleges within each district.
- Strengthen the national apprenticeship programme.
- Ensure that skills training and development meet the needs of industry, commerce, and the public sector.
- Promote innovation, science, and technology development.
- Strengthen and incentivise educational research, innovation, and development.
- Improve technical educational infrastructures focusing on mining, agriculture, entrepreneurship and the digital or knowledge economy.
- Promote and incentivise high investment levels in technological research and development targeted at critical sectors of the economy.

### STUDENT EDUCATION GRANTS

Zimbabwe prides itself as a country with one of the highest literacy rates. Under President Saviour Kasukuwere's government, the country shall strive to become an important educational hub. In this regard, we commit to:

- Establish a national fund covering equitable student bursaries/loan access.
- The repayment of student loans linked to a student's salary upon working.


## **HOUSING POLICY**

Zimbabwe has an urbanisation rate of 2.3084% pa (World Bank) due to increased rural-to-urban migration, poor policy formulation, and corruption. As a result, the housing backlog is estimated to be over 1.5 million people on the government's national housing waiting list. We believe everyone has the right to a decent, secure home; however, most people in urban areas need access to a good home for many reasons. Providing adequate and decent accommodation is a fundamental human right.

· Zimbabwe has a monumental task in addressing its national housing commitments, exacerbated by inadequate social amenities infrastructure to cater to the deficit, including rehabilitation and upgrading existing services.



• Rural to Urban Migration and unemployment are leading factors contributing to urban poverty, homelessness, sprouting informal settlements in locations unsuitable for living and creating slums, overdevelopment in residential areas and sub-standard unaffordable temporary dwellings. The latter is the direct result that marginalises and creates the societal distinction of the "have and the have-nots" – a gross miscarriage of justice.



- High levels of patronage and corruption have resulted in many Zimbabweans being duped of their savings. The rise of the land barons who have corruptly acquired urban land and sold it at exorbitant prices.
- Corruption has also led to poor urban planning leading to settlements in sensitive ecological zones (e.g., wetlands) and pollution of the river systems. Poor planning also means that bulk infrastructure such as roads, water and sewerage are not easy to provide, leading to urban sprawl and squalor.

#### Our success as a nation is possible, and we will ensure that:

There is benefit across the board by ensuring the natural resources are leveraged economically with our pledge to ensure that investment and development are spread evenly across the country.

Each region/province will be empowered to have an economic development blueprint, including a housing development and financing policy to ensure building housing with public funding is an effective way to ensure everyone has suitable housing. These projects must meet financial, social, technical, and environmental standards. Housing construction is the most significant part of the construction industry, including public, private, infrastructure, and industrial and commercial properties.

Public projects are a crucial source of employment provided by the government. It's essential to address the connection between housing and the environment, as both sectors benefit from each other and cannot be addressed separately.

Our ambition is for resilient, sustainable housing, which promotes:

- Environmentally robust construction through
- Using materials with a low carbon footprint and adopting modern construction methods.
- Building off-grid and encouraging the use of renewable sources of energy,
- Enforcing stringent planning measures to curb construction in areas that are unsuitable or impact the environment wetlands.
- The ability to contribute to the economy through employment, thus addressing societal challenges and the environmental impact.
  Enables us to embrace building to create a better future for both the users and inhabitants of the facilities.

#### **Reform, Revive & Rebuild**

Our agenda will therefore address constraints which are roadblocks impacting the construction of ICT, electricity, roads, water, and sewer.

#### **Reforming the institutions and departments to:**

- Eradicating corrupt practices adopted by officials in public office in conjunction with unscrupulous 'Land Barons' to disenfranchise citizens.
- Restoring the institutions' confidence, integrity, and image by improving service delivery and transparency.
- Implementing a robust Land Use Policy by separating land uses and bureaucratic procedures in town and rural planning for efficiency.
- Embracing innovation and flexibility in land delivery and management multi-storey apartments with lower land area footprint and promoting a renewable energy source for household needs, recycling and reusing.
- Reviewing and reforming, Urban & Rural Planning to enable the adoption of effective Town Planning, Building Regulations, and minimum build standards.
- Reforming the Housing Policy to encourage private/ commercial homebuilders to construct low-income homes that meet the requirements of public authorities.
- Ensuring that access to land and title is reformed to be collateralised for mortgages.

#### The Work Ahead

Most of us are familiar with the impact of the housing crisis. It affects young families who have to live with their parents, people who rent sub-standard housing, and those who build in areas with restrictions.

#### We will set out to ensure:

- The provision or right to accommodation by reviewing and addressing outdated policies such as the town and rural planning policies and building standards.
- Through local government devolution, address the demand for services

- and establish an executable and viable solution to meet the prevailing and future circumstances to ensure a resilient and robust intervention that is area specific..
- A new mandate is established for Local Government to adopt regionspecific policies when planning rural communities and their access to services by providing solutions, strategies, laws, policies, and programmes.
- To act on every front by reviewing
- The affordability of building your own house and tenure that can be collateralised where there is access and policies for banks to provide mortgages to prospective homeowners.

# SPORTS

Sports and recreation provide individuals and communities with opportunities to improve their income, physical and mental well-being, development of confidence and social skills, social inclusion, community development and diversion from antisocial behaviour. Local government will have a central role to play, especially in rehabilitating public infrastructures.

We will increase investment and participation in sport and recreation by our citizens as follows:

- Reform the institutional arrangements around managing sporting activities, including building new skills and capacities where required.
- Rehabilitate and develop new sporting and recreational facilities in urban and rural sectors.
- Invest in each province's world-standard national sporting arena that meets global standards.
- Promote the hosting of regional and global sporting events.
- Establish a comprehensive sports development policy starting at the school level.
- Incentivise the private sector to sponsor and develop facilities through partnerships.
